Average Package Shoot \$500.00* ** ***

This package will include photography of a 3 bedrooms / 2 bathrooms house, interior and exterior. Production time is included to produce up to 12 panoramic photos that will be used to create the virtual tour.

Mid-Size Package Shoot \$550.00* ** ***

This package will include photography of a 4 bedrooms / 2 bathrooms house, interior and exterior. Production time is included to produce up to 13 panoramic photos that will be used to create the virtual tour.

Estate Package Shoot \$600.00* ** ***

This package will include photography of a 5 bedrooms / 3 bathrooms house, interior and exterior. Production time is included to produce up to 15 panoramic photos that will be used to create the virtual tour.

Executive Package Shoot \$650.00 * ** ***

This package will include photography of a 6 bedrooms / 3 bathrooms house, interior and exterior. Production time is included to produce up to 16 panoramic photos that will be used to create the virtual tour.

* Larger properties or more complicated shoots may require more time and will be quoted at a higher rate.

**All packages will include a web link to the virtual tour and free webhosting for the first 6 months, after which there will be a nominal fee of \$5.00 a month.

*** All packages will require a \$75.00 check deposit made out to NAS Photography, LLC. The check must clear the bank before the photo shoot. The balance will be due at the completion of the project. Cash is also acceptable.

Additional panoramic photos \$50.00/each

Additional photos requested that exceeds the package maximum stated above.

This applies to taking the extra photos and the production time to create the extra panoramic photos.

Additional digital imaging editing \$65.00/hour

This applies to removal or alteration of features or objects as necessary. We will consult you, the customer before proceeding with this option.

CD ROM/DVD \$10.00/each

In addition to the web link provided, the virtual tours can be available on CD ROM or DVD.

Scheduling and Contact Information

Please contact us no later than 24 hours before your preferred time.

At the Photo Shoot

You, or someone authorized by you, should be present at the shoot to discuss important elements of the property or areas that should not be photographed. The photographer will make a reasonable effort to remove litter, stray objects, etc. from the rooms, however, please note that this does not include making beds or arranging furniture. You are expected to have the property staging and cleaning completed prior to the photo shoot.

All properties will be shot "**AS IS**".

Your input is important when choosing the best rooms and angles to photograph. If you are not sure of what you want then consult with the photographer, otherwise photographer will use his/her best judgment and experience to decide how to best photograph the property.

After the Photo Shoot

Once the images have been taken, the photographer will review and select the best photos to create panoramic photos of the property. As soon as the virtual tour is ready, it will be moved to our preview stage and you will be notified via email with a web link to preview the virtual tour.

The preview link will exist for one week for review and editing if required.

After the one week preview period, the project will be considered completed and balance will be due.

After Project Completion

An invoice for the balance will be issued. Pay the balance in a check payable to NAS Photography, LLC.

After the check is cleared by the bank, the tour will be moved to our production site and a web link to the tour will be issued to you so you will be able to show your property to your clients. The panoramic photos will also be provided to you for your personal use only. (See rights and usage below.)

If you cancel on wanting the virtual tour after the project is completed, your deposit and panoramic photos will be forfeited and the tour will be removed from the preview stage and will be unavailable for viewing.

Cancellation of virtual tour

If you cancel on wanting the virtual tour after making a deposit, your \$75.00 deposit will be forfeited.

Rescheduling, No-Show and Inclement Weather Policy

If rescheduling a shoot is necessary, please do so with a minimum of 24 hours notice. Any shoot canceled (with no desire to reschedule) within 24 hours of a confirmed appointment is subject to a \$75 cancellation fee, or forfeiture of deposit.

Arriving late beyond 30 minutes to an appointment will be considered a cancellation, unless contacted and notified of the delay.

In the event of inclement weather the exterior photography of the property will be rescheduled at the earliest possible time.

Every effort will be made to accommodate a rescheduling.

Rights and Usage

All final virtual tour panoramic photographs will be provided to you, the Client from NAS Photography, LLC, in a digital format to be used for personal use only. NAS Photography, LLC own the rights to the virtual tours and all photos taken and produced. The Client will not have the right to sell the photographs or enter the images in photographic contests or exhibitions without written consent from NAS Photography, LLC. Any usage of the images by a third party, including but not limited to architects, builders, stagers, designers, sellers or buyers, is strictly prohibited unless approved in writing by NAS Photography, LLC.
